

Arizona Tuition Credit Statement of Privacy

Arizona Tuition Credit is committed to protecting your privacy. This Statement of Privacy applies to Arizona Tuition Credit Web site and governs data collection and usage at all Arizona Tuition Credit sites and services; it does not apply to other online or offline sites, products or services. Collection of your Personal Information

Use of your Personal Information

Arizona Tuition Credit and its operational service partners collect and use your personal information to process product orders and deliver the products requested. It is possible that Arizona Tuition Credit may also use personal information to inform you of other products or services available from Arizona Tuition Credit and its affiliates. Arizona Tuition Credit may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Arizona Tuition Credit does not sell, rent or lease its customer lists to third parties. They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

Arizona Tuition Credit may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of

the law or comply with legal process served on Arizona Tuition Credit or the site; (b) protect and defend the rights or property of Arizona Tuition Credit, including its Web site; or (c) act under exigent circumstances to protect the personal safety of users of Arizona Tuition Credit or the public.
